Disabilities	✓ Having a recognized and legally qualified disability of 33 percent or more, or an equivalent degree of disability for foreign students.
Socio-economic barriers	✓ Being beneficiary of a general study grant from the General State Administration for university and other higher studies. Being beneficiary of a grant from the Department of Education of the Basque Country, or of a grant for the schooling of students at non-university levels granted by the Department of Education of the Basque Country in the academic year immediately prior to the year in which the mobility is to be carried out or in the academic year of the mobility.
	✓ The family unit is receiving a benefit of Minimum Vital Income / Minimum Insertion Income or any other benefit of similar nature, according to the denomination adopted in each Autonomous Community.
	✓ Being at risk of social exclusion.
	✓ Belonging to a large or single-parent family.
	✓ Being in a situation of special need and social emergency.
	✓ Being a victim of terrorism, gender violence or orphan.
	✓ Being in a situation of dependency or with dependents.
	✓ Having a full-time employment contract.
Geographical barriers	✓ Being enrolled in a study center located in the Autonomous Cities of Ceuta or Melilla, or be registered in those cities, in case the enrollment is made in a remote educational institution.
Health problems	✓ Suffering from any physical or mental problems for which additional support is needed.
Cultural differences	✓ Having receive refugee status, be eligible for subsidiary protection or have filed an application for international protection in Spain, or in another country in the case of incoming participants.
